

# CCS CODE OF CONDUCT

At Cumberland Community School we care about providing a positive, encouraging, and safe learning environment that is focused on the growth and well-being of each student. Our school is a community, and as part of a community we expect everyone to consistently practice 3 basic principles: respect, responsibility, and safety:

### I will practice respect:

- → I respect others' right to learn
- → I communicate respectfully with others by using a respectful tone, words, and body language, and by listening respectfully
- → I respect the personal space of others
- → I respect the property of other students and staff
- → I respect school property, including learning materials and the school facilities
- → I respect our school hallways by using garbage cans and recycling bins
- → I wear clothing that displays respectful language and images
- → I respect and appreciate diversity and individuality of others
- → I use language/behaviour that is respectful of race, culture, gender, sexuality, and ability

## I will practice responsibility:

- → I do my best to be ready to learn each day
- → I do my best to help create and maintain a positive learning environment for others
- → I avoid gossip and spreading rumours
- → I accept adult (staff) instructions and requests
- → I understand and follow school and classroom rules
- > I take responsibility for my words and actions instead of blaming others
- → I will help others when I see that they need help

#### I will practice safety:

- → I will not use my body to hurt others
- → I will not use my words to hurt others
- → I will conduct myself in a safe manner while at school (Example: walking when inside the school)
- → I stay within school boundaries (in accordance with CCS's closed campus policy)
- → I will ensure that my teacher always knows where I am
- → I use my personal electronic device(s) in a safe way, and in accordance with CCS's cell phone policy.

RIGHTS	RESPONSIBILITIES
I have the right to feel safe in my school.	I have the responsibility to act in a safe, kind, and respectful way with both my words and actions.
I have the right to expect others to respect my personal property.	I have the responsibility to respect the property of others and of our school and community.
I have the right to learn in an environment free from illicit and illegal substances.	I have the responsibility to not be in the possession of and/or under the influence of illicit or illegal substances.
I have the right to be part of positive and supportive learning environment at Cumberland Community School.	I have the responsibility to respect others' right to learn and will do my best to avoid behaviours that disrupt the learning environment.
I have the right to be myself, and to be valued, respected and appreciated for who I am.	I have the responsibility to respect individual uniqueness in others. I have the responsibility to not discriminate against others due to their ethnicity, culture, identity, appearance, or their ancestry.
I have the right to be treated with respect, kindness, caring, and compassion (by other students and staff)	I have the responsibility to practice respect, kindness, caring, and compassion with others at CCS (students and staff).
I have the right to learn about and connect with the environment.	I have the responsibility to care for and preserve our environment.
